NOTICE OF A COMPLETE APPLICATION AND NOTICE OF PUBLIC MEETING TO CONSIDER AMENDMENT TO THE COMPREHENSIVE ZONING BY-LAW 01-86

APPLICATION NUMBER: ZBA 2026-02

TAKE NOTICE that the Council of the Corporation of the Town of Minto has received a complete application to consider a proposed amendment to the Comprehensive Zoning By-law 01-86, pursuant to Section 34 of the *Planning Act, R.S.O. 1990*, as amended.

Location of the Subject Land

The land subject to the proposed zoning amendment is legally described as CON 18 PT LOT 41 PT LOT 40: PT LOT 39 and municipally known as 5159 Minto-Normanby Townline. The subject property has a total area of 76.8 ha (189.9 ac) and is illustrated on the key map below.

The Purpose and Effect of the Application

The purpose and effect of the proposed amendment is to rezone the subject lands from Agriculture Exception (A-1) Zone to Agriculture Site Specific (A-XX) Zone to allow for the construction of a new livestock facility and manure storage (swine) on an existing farm and to permit a reduction in MDS II requirements from the adjacent Clifford settlement boundary. Additional relief may be considered at this meeting.

Public Meeting

A public meeting will be scheduled on **May 5th, 2026, at 3:00 pm.**

Oral or Written Submissions

Any person or public body is entitled to attend the public meeting and make written or oral submissions in support of or in opposition to the proposed zoning by-law amendment. Written comments should be submitted to the Town Clerk at the address shown below.

Power of Tribunal to Dismiss Appeals

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Town of Minto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting (virtual or in-person) or make written submissions to the Town of Minto before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions (virtual or in-person) at a public meeting, or make written submissions to the Town of Minto before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
