### Corporation of the Town of Minto

### By-law 02-45

Being a By-Law to regulate the disposal of waste in the Town of Minto.

Whereas in the Municipal Act, R.S.O. 1990, chapter M.45, section 210, subsection 82 authorizes the Council of a local municipality to pass by-laws for prohibiting littering on private or municipal property;

Now therefore the Council of the Corporation of the Town of Minto enacts as follows;

#### 1. Definitions

- 1.1 "Disposable solid waste" shall mean and include garbage, refuse and litter.
- 1.2 "Litter" shall mean large or small quantities of unwanted waste carelessly left lying around.
- 1.3 "Solid waste" shall mean and include all organic waste subject to decay, recyclable solid waste whether it be household, commercial, construction and demolition waste. This shall also include tree limbs and shrubs.

### 2. General Duties and Obligations to Comply

- 2.1 No person shall spill, scatter, deposit, throw, cast, lay or cause to be thrown any solid or disposable waste on any street, lane, alley, laneway, roadway, road allowance, public or private way, or in any public square, place or private lot.
- 2.2 Materials applied to land for agricultural purposes are exempt from the provisions of this By-Law;

### 3. General Provisions

- 3.1 The Municipal law Enforcement Officer(s) appointed by the Corporation of the Town of Minto shall enforce this by-law.
- 3.2 Every person who contravenes any provision of this by-law is guilty of an offense and on conviction is liable to a fine as provided for in the Provincial Offences Act., R.S.O. 1990 Chapter P.33
- 3.3 This by-law shall come into effect upon receiving its short form wording.
