



County of Wellington and Town of Minto Notice of Project for the Reconstruction of Wellington Road 123/Main Street East and West, Palmerston

The Project:

The County of Wellington and the Town of Minto, in partnership, have initiated planning for the Reconstruction of Wellington Road 123 (Main Street East and West), between approximately 400 meters west of Toronto Street to 140 meters east of King's Highway 23, Palmerston (Project), as identified in Figure 1, below. Reconstruction will generally include the full replacement of underground infrastructure (existing watermain, sanitary and storm sewer), including new services to property line for properties serviced from Main Street E/W, as well as surface works including but not limited to the roadway cross-section, sidewalk, and driveway entrances.

This strategic undertaking is prompted by the anticipated population growth in Palmerston and the surrounding areas, which necessitates critical upgrades on Main Street E/W to adequately service the existing and future population and optimize vehicular and pedestrian traffic flow, consistent with the primary design objective of sustainable urban development and transportation infrastructure.

The Process:

The Project is currently in the planning, engineering, and design phase. During this phase, the Project team will identify, evaluate and make recommendations to improve traffic and pedestrian movements through Palmerston, including consideration of reducing vehicular speed and enhanced intersection movements, while maintaining adequate traffic and pedestrian flow through the downtown core.

To ensure community engagement, the Project prioritizes consultation with public stakeholders, including those directly affected by the Project, including but not limited to the local population, users of the road and adjacent property owners/residents and businesses. This collaborative approach is fundamental in any municipal project to ensure responsible decision making.
