Exterior:

Power Wash Entire Exterior Steel Surface

Application of Primer/Sealer Coat, Intermediate Coat, and Top Coat

Interior: (Repairs)

Clean Out Tank Interior and Spot Repair any areas where the Interior Coating has failed

Mandatory Requirements:

To be successful, the Bidder must meet the following mandatory requirements. Failure to meet these requirements will result in the Bid being disqualified.

Demonstrate through satisfactory references that the Bidder has completed at least five (5) similar projects in the last ten (10) years. The references must be, at a minimum, similar in size and equal in-service requirements to this tender (interior/exterior repainting of elevated storage tanks).
